Other Bylaws Provisions That Function as Eligibility Gates

2. **Bylaws §4.02(a)** — Directors must be duly elected by Members in Good Standing, or Board-appointed to fill a vacancy.
3. **Bylaws §4.02(b)** — No Director may serve more than two consecutive elective terms; someone term-limited out cannot be appointed to fill a vacancy for one calendar year after the last term expires.
4. **Bylaws §4.06** — A candidate must be a Member in Good Standing to obtain and submit an Application for Director.
5. **Bylaws §4.05, closing paragraph** — A Director previously removed under §4.05 must meet §4.02(b) and §4.04(a)–(c) to requalify as a future candidate, and only after the balance of the original term plus one additional term has passed.
